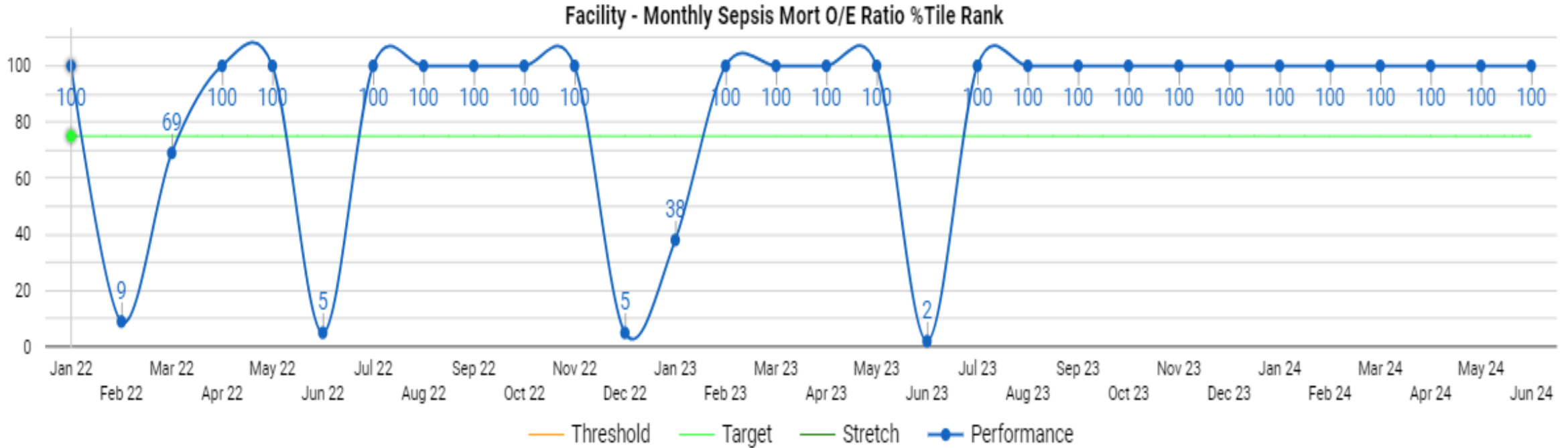

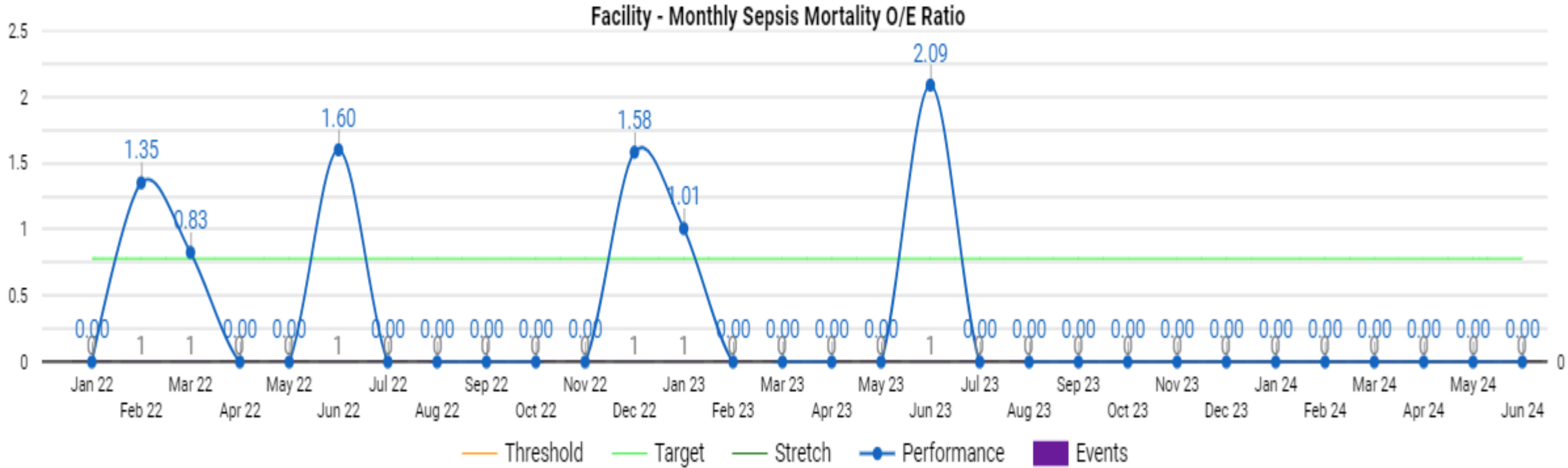

What did you do:

1. Sepsis screening at triage - began monitoring
2. Reviewed the data-educated all nursing staff in ED regarding sepsis screening at triage
3. Distributed tip sheets regarding compliance with the sepsis screening
4. EHR has a BPA (best practice advisory) alert built
5. Tracked/trended all fallouts-days of week, time of day, nursing staff working so we could provide targeted education and resources
6. Held weekly Quality market meetings to ensure barriers were addressed
7. Implemented a “shout-out” on the Emergency Department Huddle Board for all nursing staff that were at 100% for each month
8. Held monthly market Sepsis meetings that include Medical Providers, Nursing Leaders, Quality Managers, Lab Managers and Pharmacists that assist in reviewing fallouts, discussing barriers and providing resources for facilities that need more assistance
9. Nominated Sepsis Champions in the ED
